- 1. As a member of the Company you are entitled to appoint a proxy to exercise all or any of your rights to attend, speak and vote at a general meeting of the Company and any adjournment thereof. - 2. Appointment of a proxy does not preclude you from attending the meeting and voting in person (subject to restrictions or recommendations as a result of the Covid-19 situation). If you have appointed a proxy and attend the meeting in person, your proxy appointment will automatically be terminated.
